3. Composition / Information on Ingredients	
Warnings:	For <i>in vitro</i> diagnostic use only. Do not pipette by mouth. Handle laboratory reagents in accordance with Good Laboratory Practice. May cause irritation to skin and eyes, may be irritating to mucous membranes and upper respiratory tract. Avoid contact with skin, inhalation and ingestion. The Buffer Solutions (R1a & R2b) contain Sodium Azide (<0.1%w/v). The GLDH Reagent (R2a) contains sodium azide (0.2%). Sodium azide reacts with lead or copper plumbing to form potentially explosive azides. When disposing of such reagents flush with large volumes of water to prevent azide build up. Exposed metal surfaces should be cleaned with 10% sodium hydroxide.
