Warnings:	<p>For <i>in vitro</i> diagnostic use only. Do not pipette by mouth. Handle laboratory reagents in accordance with Good Laboratory Practice. May cause irritation to skin and eyes, may be irritating to mucous membranes and upper respiratory tract. Avoid contact with skin, inhalation and ingestion.</p> <p><u>Buffer and Antibody Reagent</u> The Buffer and Antibody Reagent contain sodium azide (<0.1%w/v). Sodium azide reacts with lead or copper plumbing to form potentially explosive azides. When disposing of such reagents flush with large volumes of water to prevent azide build up. Exposed metal surfaces should be cleaned with 10% sodium hydroxide. As the Sodium azide is in an acidic solution harmful fumes may be given off. Inhalation of fumes must be avoided.</p> <p><u>Calibrator</u> The serum in this kit is of human origin. This serum has been tested for the HIV (Human Immunodeficiency Virus) Antibody, HBsAg, and HCV and found to be non-reactive. However as no method can offer complete assurance as to the absence of infectious agents, this material and all patient samples should be handled as though capable of transmitting infectious disease and disposed of accordingly.</p>
